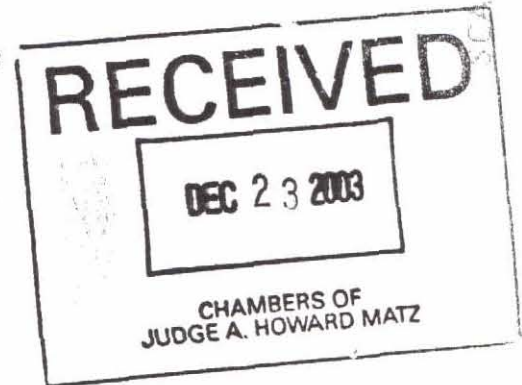

I am writing to inform you of an issue regarding studies conducted by a Forensic Psychologist at the Federal Medical Center, Devens, Massachusetts. Specifically, an investigation by the Bureau of Prisons Office of Internal Affairs recently revealed that there is sufficient evidence to question the credibility and accuracy of a psychological evaluation conducted by Dr. Thomas Patenaude.

This internal investigation could call into question the credibility of other psychological evaluations conducted by this psychologist. Our records show that this psychologist issued a report in a case before your court: United States v. Steven William Sutcliffe, Case No. CR 02-350(A)-AHM, concerning defendant Steven William Sutcliffe, Register Number 02837-049. Accordingly, we bring this information to your attention for any action the court may deem appropriate. A copy of this letter is being sent to the counsel of record.
